

INFORMATION NOTICE ON THE PROCESSING OF PERSONAL DATA

F.A.R.T. Srl, based in Via Terraglio n. 193, 31022 – Preganziol (TV), as the owner of the processing of your personal data (hereinafter "Data Controller"), issues this information in compliance with the European and Italian regulations on the protection of personal data, in order to let you know the purposes and methods of processing of personal data that you may communicate while browsing this website (hereinafter "Site").

Please note that this information refers only to the Site and not to third party websites, which may be accessed by the User through links in it.

DATA CATEGORIES

Navigation data

The computer systems and software procedures used to operate this website acquire, during their normal operation, personal data whose transmission is implicit in the use of Internet communication protocols. This is information that is not collected to be associated with identified interested parties, but which by their very nature could, through processing and association with data held by third parties, allow users to be identified.

This category of data includes, for example, IP addresses or domain names of the computers used by users connecting to the site, the addresses in Uniform Resource Identifier (URI) of the requested resources, the time of the request, the method used in submitting the request to the server, the size of the file obtained in response, the numerical code indicating the status of the response given by the server (good order, error, etc.) and other parameters related to the operating system and the computer environment of the user.

These data are used for the sole purpose of obtaining anonymous statistical information on the use of the site and to check its correct functioning and are deleted immediately after processing. For needs related to operation and maintenance, the Site and any third-party services used by it may collect System Logs, which are files that record the interactions and that may also contain Personal Data, such as the User IP address.

Data provided voluntarily by the User

Sending e-mails to the addresses indicated on the Site - optional, explicit and voluntary - involves the subsequent acquisition of your e-mail address, necessary to respond to requests, as well as any additional personal data communicated. The Site contains forms to fill out, complete with specific information on the processing of personal data and, where necessary, requests for consent: we therefore invite you to review it before proceeding with the use of the form.

Cookies

In compliance with the Provision of the Guarantor for the protection of personal data n. 229 of 8 May 2014, on "Identifying the simplified procedures for the information and the acquisition of consent for the use of cookies", we inform you about the use of browsing cookies on this Site.

What are cookies.

A cookie is a small file that is sent to your browser and saved on your device when you visit a website such as www.fart-neon.com. Cookies allow efficient operation of the Site and improve its performance, provide information to the site owner for statistical or advertising purposes, mainly to customize your browsing experience by

remembering your preferences. The Site uses different types of first-party cookies (prepared and managed by us and third parties (prepared and managed by third parties based on their privacy policy and not under our control): below is an explanatory table

TYPE OF COOKIE	FUNCTION
technical cookies (session or navigation)	They guarantee the normal navigation and use of the website and are therefore aimed at making functional and optimizing the same navigation within the site.
functionality cookies	They are strictly necessary to provide services explicitly requested by the user.
first party analytics cookies	They are used and compiled exclusively by us to collect information, in aggregate and anonymous form, on the number of users and on how users visit the site.
third-party analytics cookies (Google Analytics)	We have adopted appropriate tools to ensure that the treatment with these cookies is carried out for mere statistical purposes.

Enabling and disabling cookies from the Browser.

Most browsers are configured to accept, control or possibly disable cookies through settings. We remind you, however, that disabling cookies or navigation functional ones can cause unsatisfactory operation of the site and/or limit the service we offer.

PURPOSE AND LEGAL BASIS OF TREATMENT, NATURE OF DATA SUPPLY AND CONSEQUENCES IN CASE OF REFUSAL

The Controller will process your data to facilitate navigation and to provide the services you may have requested through the forms specially prepared on the Site. Apart from that specified for navigation data and technical cookies, within the sections of the Site set up for particular services at your request you will be free to provide your personal data for the purposes set out in the respective information, but their failure to provide may make it impossible to obtain the requested service.

DATA RETENTION PERIOD

The Data Controller will process the personal data collected through the use of the Site for the time strictly necessary to achieve the purposes for which it was collected and, once completed, for any time established by the applicable regulations.

SCOPE OF DATA COMMUNICATION AND CATEGORIES OF ADDRESSEES

The Data Controller will not disseminate the data, but intends to communicate it to internal figures authorized to process the data according to their respective duties, as well as to external subjects who may need to communicate the data. Those recipients, if they were to process data on behalf of the Data Controller, will be appointed as data controllers with a specific contract or other legal document.

DATA TRANSFER TO A THIRD COUNTRY AND/OR AN INTERNATIONAL ORGANIZATION

Personal data shall not be transferred to non-European third countries or international organizations.

RIGHTS OF INTERESTED PARTIES

You have the right to ask the Controller to access your personal data and to correct them if they are inaccurate, to delete or limit their processing if the conditions are met, to oppose their processing for legitimate interests pursued by the Data Controller, and to obtain portability of data personally supplied only if subject to an automated processing based on consent or contract. You also have the right to revoke the consent given for processing purposes that require it, without prejudice to the lawfulness of the processing carried out until the time of revocation.
