

DISCLOSURE ON THE PROCESSING OF PERSONAL DATA:

F.A.R.T. Srl, based in Via Terraglio 193, 31022 Frescada (TV), as a data controller of personal data ("Data Controller"), is providing this disclosure to you (a "Data Subject") in compliance with European and Italian regulations on the protection of personal data.

Purpose and Legal Basis of the Processing

As Data Controller, we process the personal data of data subjects for various purposes:

- 1) to fulfil the pre-contractual actions requested by data subjects, such as, for example, sending information on products or services (including sending brochures, catalogues and/or other company information material) or quotations: consent is not required because such processing is necessary to respond to the data subject's requests;
- 2) using the email address of the data subject to send its newsletter that contains information on products or services, as well as promotions or invitations to events it will attend: for this purpose, the data subject's express consent is required;
- 3) managing any disputes: consent is not required because the processing is necessary to fulfil this purpose.

Data Retention Period

As Data Controller, we may process your data for the time necessary to pursue the above purposes and in particular according to the following timing:

- if you request information, we will process your data for the time necessary for us to fulfil your request;
- if you subscribe to our newsletter, we will process your data until you unsubscribe and, in any case, for the time strictly necessary to achieve the above purpose, after which your data will be deleted or anonymized.

Without prejudice to the above, we may store your data for the time needed to settle any disputes that may have arisen (however such disputes are settled).

Methods Used to Provide Data and Consequences of Refusal

If you do not provide your data for the purposes described in points 1) and 3) we, as Data Controller, will not be able to fulfil such purposes. Providing your data for the other purposes is optional: if you do not, the Data Controller will not be able to perform the corresponding actions but will still be entitled to pursue the purposes described in points 1) and 3).

Categories of Recipients

We, as Data Controller, will not disclose your data, but intend to communicate it to figures within our company to process your data as required by their roles, and also to sales agents, commercial information companies, associations and/or business organizations, professionals or service companies, as well as public and private bodies, also as required by inspections and audits.

If we request these recipients to process your personal data on our behalf, we will appoint them as data processors by contract or other legal act.

Transfer of Data to Other Countries or International Organisations

We will not transfer your personal data to non-European countries

Rights of Data Subjects

As a Data Subject you may ask us, as Data Controller, to be able to access your personal data, to correct any inaccuracies in it, to delete it or restrict its processing if the required conditions are met, to object to its processing on the grounds of legitimate interests pursued by the Data Controller, and to obtain the portability of the data you have personally provided only if it is subject to automated processing based on consent or contract. You may also revoke the consent you have given to the processing that requires such consent, without prejudice to the lawfulness of any processing carried out before you revoke your consent.
